1. APOLOGIES & ANNOUNCEMENTS & DECLARATIONS

Apologies received from Cllr Brazier, Cllr Reeves Chair & Cllr Rump.

Cllr Henchley had brought a matter to the attention of the Clerk outside the meeting to which the Clerk readily agreed was incorrect in the March minutes, it was the word <u>resignation</u> be replaced with the word <u>retirement</u> -as a true fact

Incorrect statement in March minutes- to correct as the previous statement. There were no declarations and the fact Cllr Henchley had clarified his resignation as now past President of the CHFC as from January 2007, although still a member.

The Clerk apologises for this error of fact in the minutes-that is now corrected.

The Chair welcomed a new Cllr Dennis Horner to his first meeting of the new council and hoped that he would find the position of serving the on the Colney Heath Parish Council both rewarding and fulfilling.

The Chair also reminded members that this meeting will be guillotined at the last item on the agenda reached at 9pm in order the Annual Statutory Meeting can take place soon after that time and be completed as part of this evening's business.

2. MINUTES

3 MATTERS THE CHAIRMAN MAY BRING BEFORE THE COUNCIL

3.1 Election and Vacancies for Co - Opted Members

Vacancy for Co-opted Members due to resignations and retirements

The Clerk advised member that there were now two vacancies and that he had names of two candidates so far;-

The co-option process requires formal notices to go out after the date of the elections and to be on public display for 14 working days excluding Bank Holidays and w/ends. Notices are to be put out on 11th May and will expire on 31st May in order that those who have applied to join by co-option can be considered at the next full parish council meeting held here on 7th June at 7.30pm. (Those candidates will be asked to attend)

3-2 Community Park

The Clerk advised members the progress on the completed works, a new field gate to go in; the tree felling clearance caused some controversy with residents in St Marks Close with complaints about the cores in the river. All of which were removed by the contractors. The reasons why this happened are unclear, vandalism or theft of cores might be the reason. Some cores had finished up further down river. Cllr Brazir and Clerk had several conversations with residents and matters were amicably resolved. A Teddy Bears Picnic for children from the JMI and T/Tots on the 6th June a ribbon will be cut to celebrate the park refurbishment. The Mayor is invited to come to the celebrations, Cllr Brazier had suggested a tree planting, Clerk to suggest to CMS, who it is known oppose having reduced trees near the river bank so this might not be done.

3.3 Chronicle Magazine and Web Site

It was agreed that we ask Mr Rodway to the next meeting on 7th June to give details of the upgrades planned.

3.3 Herts Rights of Way and Mr Day re-Footpath 21

The Clerk informed members that progress was being made with settlement of the landscape and path route dispute between Herts Rights of Way unit and Mr Day.

3.4 Colney Heath Parish Council 60th Anniversary-1947-2007

All members present remarked how the event was a success; the Clerk said he had received many letters and cards including the Mayor and WI thanking the council. It was decided to leave this over until the return of Cllr Rump at the next meeting for any comments. Those who helped and contributed have been sent letters of thanks.

3.5 Tyttenhanger Sign

The completion of the brick plinth was just in time for the celebrations on 19th April and the dedication by the Mayor Cllr Alison Steer and blessing by Rev James Spanner The final names plate needs a suggestion to the appropriate wording and the credits. An explanation plate is attached to one side of the post, it is planned the other going on opposite side to give the information on names, dedication and contribution data. We await the invoice from the building contractor for the excellent plinth brickwork.

3.6 Roestock Park

It is planned to have a session of "Larks in the Parks" on Sunday 1st June as part of the 60th to encourage local families to have a day out of fun. Cllr Brazier, Cllr Day and Cllr Horner Cllr Crump have all pledged help on the day. Kim Parker-Mead is coordinating with SCADC Arts on the fine detail attending meetings on set up plans and is on of the co-organisers. It is the intention to have five simple amusement or display ideas plus the circuit entertainment laid on by SCADC Arts. All HSWA is to be done for us by the Arts group; we are expected to provide the site and a base point. More details will be given at the next meeting. The Clerk mentioned he is on annual leave at that time but he was giving all background help to the Assistant Clerk.

3.7 Grazing on Furze Field

The Clerk reported on the open day event15th April with cattle and information tents in conjunction with CMS and Herts Commons Grazing Group we are involved with. The day was a success, sunny weather and about 150 people turned, mostly families up to see the animals and gather information. The completed questionnaires suggested 24 people were in favour of the project and no objections. This is all a part of the consultation and public involvement essential for the future of the DEFRA project.

3.8 Annual Beating of the Bounds

Members were advised of the annual ceremony on Sunday 13th May starting at 2pm starting at the office from 2pm and finishing up at the St Marks Centre for tea. All are invited to join for a walk around the common boundary and check the CHPC markers.

4. FINANCE

The Clerk gave information on the following financial matters which was supported by the relevant information and data reports to each member;-

4.1 BUDGET & PRECEPT 2007-2008

The Clerk reported having received and banked the precept sum of £135,000.00

4.2 Monthly Expenditure

The Clerk gave members details of the April 16,939.21 & May £7832 expenditure and income figures including vat of £920.61 (the vat sum is recoverable periodically) Noted on a separate sheet for March 2007 as seen by the members was approved:-

Investments: -

The Clerk advised placing £175,000 on Treasury Reserve re-invested-one month fixed until 1st June 2007 at 4.089% yielding £719.00 in that period.

4.3 Progress of Audit 2006-7

The Clerk was able to give an overview at the APM reported the Auditor is returning again on 20th June to assist with the finalisation of the accounts for final submission to Lubbock Fine after in July/August when we should be up to date with our audits.

4.4 Progress of VAT Recovery

The Clerk advised there is a reclaim to be completed once the petty cash is done.

4.5 Parish Accounts

The Clerk said that details and statements of the Parish Accounts may be inspected here now if members wished and at the office at other times. The Clerk was able to answer member's questions regarding the finances, several one off payments and receipts this month making the income & expenses about average this month.

4.6 Charles Morris Hall Grant

The Clerk advised members we are awaiting materials invoices as part of the £8000 grant, as agreed in order the VAT element can be saved by council from payments.

4.7 Other Financial Matters;

There was an invoice dispute with Herts Highways Partnership over the works at the Tyttenhanger Sign installation and use or non use of traffic lights, a sum of £300 is in dispute. The Clerk said he would like to take the matter up at the next HHWP meeting direct, Members accepted and suggested it be left to the Clerk to negotiate a refund **Payroll year end-Annual Salary Review-Staff matters**

The Clerk advised office time is busy with HMCR payroll year end for 15 employees Staff COL wage and salary increases are still under national review and (NALC) the authorising body are being challenged over Local Authority percentages that suggest a 1.8% when 5% is being demand We have budget provisioned for 4% but any increases will have to wait and be back dated until national agreement is reached. The Clerk advised the new salary scale of the Assistant Clerk had been reviewed to 25 points and 25 set at hours per week up from 22 points in line with agreed ratios for the position. The Clerk scale remains static at 34 points @|32 hours p/week with no scale increase this time. Both positions carry flexible time working away from the office.

6-1 Parish Warden Report

Members were circulated with a copy of the reports. Mainly general tasks removal of litter and FC pitch marking and regular tasks of the job.

6-2 Parish Commons Ranger Report

Report circulated at the meeting various new spring activities noted on the common.

6-3 Parish Gardner and Tennis Courts Attendant Reports

Report circulated- low use of courts and flower beds flourishing is the main comment.

6-4 Church & Graveyard Keepers work/time sheet

No specific report, satisfactory work and clearance continuing.

6-5 CHPC Grass Cutting Contract

The contract has had a 3% cost uplift as agreed in 4 year contract applicable this year for increased operation and fuel costs.

6-6 Commons Stewardship

The Clerk has attended a meeting of the new Joint Commons Grazing, other parish's keen to have cattle on commons also St Stephens and Chorleywood PC have declared their intentions to graze cattle in the future. The purpose of this group via CMS is to network and assist one and other. Next week the Clerk is going off with the group to High Beeches in Epping to view a project of grazing Highland Cattle, instigated by the City of London. This is a major conservation project and significant to research.

6.7 Recreation Areas

The priority this parish year is to replace Sleapshyde Recreation area. Equipment had to be removed being unsafe and rotting The Clerk said that both he and Cllr Corley (Resigned) have been in discussions with SCADC Department of Leisure to get part funding on this urgent need. Our annual ROSPA Inspections are due to be done this month, results awaited with interest considering the refurbish amount spent last year.

6-8 Footpaths P3 and Rights of Way-Bridleways-BOAT-RUPP

Footpath 21 issues reported already. Installation of DDA gate at Community Park Clerk to get John Ely and Highfield Hall staff to install, they have already done works on F/p 16-18 the Alban Way with similar gates.

Gloucester Park

The Clerk informed he has not had an opportunity to view Gloucester Park problems.

7 HIGHWAYS-TRANSPORT-FOOTPATHS AND VERGES

7-1 Highways & Maintenance & Signs local Roads or major route reports

No meetings to report from HHWP since last April, next meeting to schedule soon Various issues reported but unclear if there has been any completion of the jobs. The closure of Coursers Road on 4th June for up to 15 days will give the area other traffic problems. This is essential re-surfacing work. Cllr Henchley is keen to see the works of ditch clearance on Peggy's Path-Station Road-Smallford Lane completed-this is long outstanding works. He remarked we have had so many promises! An issue for the next HHWP meeting-again! Repairs to pot holes in the High Street, some done but overall the repairs are only just satisfactory and not all have been executed.

Response Crew

Details given last time-we have not called the crew out yet.

Traffic Management

Chevron signs at Coursers Rd/Common & Bridge end remain un-repaired-demolished by accident in February 2007.

Cllr Horner has taken on role of Chair to this working party. Clerk has asked to be passed by as a regular driver in order to deal with parish work. Willing to remain as stand by reserve in case of problems or sickness- offered to resume later in year if no further volunteers found. Cllr Horner is actively trying to seek another bus where seats are left in permanently.

8 PUBLIC QUESTIONS

Mr Becker asked about a litter picker in the village-he was told that Mrs Brazier and Cllr Brazier do sometimes undertake a voluntary litter pick. Cllr Crump also arranges an annual pick with volunteers and this is probably about due. In Colney Heath we do not get services from District Council on this such as district contractor O'Connor.

9 COUNCIL BUILDINGS-ORGANISATIONS & TRUSTEE MATTERS 9-1 High Street Recreation Area Pavilion and CHFC

The Clerk said that he had received estimates from the club via Cllr Brazier for the complete renewal of the shower area. Costs were in the region of £5000.00. It was suggested by the Clerk that this was not budgeted for in view of the short lease extension until April 2008. Members may wish to defer to the next full council with complete attendance and debate this in June. The Clerk was instructed to write to the club expressing disappointment at the material changes that had taken place without the landlord's permission. This action is at risk of invoking the short extended lease its terms, however temporary. The members are asking for an explanation, and the issue should have a formal arrangement. The Clerk was concerned at the use of a drop arm barrier gate (not type specified) that are considered dangerous. He said it will have to be removed as this is a public place, as Clerk he is ultimately liable in law. Cllr Crump intimated the Clerk or the Council should not be put in this position and the club must be put on notice to remove the structure. He also wanted the small shed moved back towards the main pavilion building, as agreement for it was not granted.
