Further to your email below regarding the proposals in Bullens Green Lane. I have had a response from the scheme engineer and after considering all of the comments received and the queries you have raised they have the following response:

*The proposal is in line with Speed Management Group consultation. However, if any road safety concerning speed issue still persists, considering the driver's behaviour, road safety will look at the design again at a later stage.*

The scheme engineer has made the decision to progress this scheme to the implementation stage in its current form and in the coming weeks either a letter will be sent out to the affected area or site notices will be placed within the vicinity of the proposals. An advertisement in the local press will also be placed which will give you more information should you wish to comment further.

I am writing on behalf of the Colney Heath Parish Council who reviewed and debated the proposal at the Parish Council meeting earlier this month. We have seen the response sent to you by the 4Colney Heath Residents Association and the Parish Council would like to support and endorse the view submitted.

Councillors remain concerned about the confusing signage when driving in either direction of Bullens Green Lane and that it appears you can drive and a variety of speeds depending on which direction you are travelling, they have asked for this to be urgently looked into as a matter of urgency. I have also been asked to highlight the lack of pavement at this location and that due to the new development and this lack of pavement the whole Council unanimously requests that the entire length of Bullens Green Lane be reduced to a 30mph.
